In relation to approval of the sailplane-intended FLUID POWER A14 oxygen equipment, we advise of a possibility to install this equipment in PW-5 Smyk sailplanes.

II

With regard to the above, this bulletin introduces the following revisions to descriptive and operational documentation of sailplanes provided with FLUID POWER A14 oxygen equipment:

1. Supplement to Sailplane Flight Manual, doc. No. PW-5/IWLU-7/1/08 „Operation of FLUID POWER A14 Oxygen Equipment”
2. Supplement to Maintenance Manual, doc. No. PW-5/IOTU-3/1/08 „Maintenance of FLUID POWER A14 Oxygen Equipment”
3. Limitation placard.

III

Prior to installation of this modification the installer must determine that the interrelationship between this modification and any other previously installed modification will introduce no adverse effect upon the airworthiness of the product.

The installation of this modification by third persons is subject to written permission of the ZS JEZOW.

Accomplishment instructions:

1. The work related with sailplane adaptation for installation as well as installation of FLUID POWER A14 oxygen equipment shall be accomplished by Manufacturer on User's request.
2. The work may be accomplished by User on his own in compliance with requirements specified in para. 8.3 in Sailplane Flight Manual.
3. In accordance with the order placed by the User, the Manufacturer shall deliver:
 - elements for equipment installation in sailplane together with oxygen installation
 - Supplement to Sailplane Flight Manual, doc. No. PW-5/IWLU-7/1/08
 - Supplement to Sailplane Maintenance Manual, doc. No. PW-5/IOTU-3/1/08;
 - Limitation placard.

If a sailplane is provided with the oxygen equipment, make an entry in the Sailplane Log Book about accomplishment of this bulletin.
